Chairperson's Message

主席的話

Hong Kong has experienced a series of unexpected events in the recent years. Some friends decided to immigrate with their families, while others have stayed behind. A shortage of manpower is the real problem which organizations are facing. In recent years, there is a significant loss in active members, acquiring new members is a never-ending project.

In times of adversity, young people can feel a lot of pressure, they may sometimes be discouraged and even give up hope. As a Muslim organization we strive to uplift people's spirit through religious education and strengthen their faith so that they can face the uncertainties of life with presence of mind, stay calm and persevere when faced with challenges.

The COVID-19 pandemic has also taken a toll on our youth. Closure of schools, reduced opportunities for socialization and physical activities have reduced the interaction among them with some feeling of loneliness and helpless, anxiety and depression have also increased, while others become more passive and isolated. In such times we should encourage and support our youth, help them to build their faith and guide them on the right path. It's our collective duty to look after our youth and I seek guidance and help from Allah to support us in these challenging times.

Most of our activities have been affected or cancelled due to the COVID-19 pandemic. Despite the many hurdles faced, HKIYA still managed to form a cricket team called "Tin Shui Wan United" for our Muslim youth. With our passion and determination, what was impossible became possible with the grace of Allah. To improve the physical and spiritual qualities of the team-members, HKIYA had arranged a three-day and two-night summer camp. Through some games and activities, team members learned to maintain a positive attitude of self-improvement and built a strong team spirit. The camp created an excellent opportunity for coaches and team members to exchange ideas.

Overall, HKIYA will continue provide a suitable platform for our Muslim youth through cultivating them to learn and enrich their Islamic knowledge, building good leadership, strengthening their bonds and making a significant contribution to the society in the future.

這幾年香港經歷了重大的轉變，社會上發生意想不到的變化，令人開始思考未來的路。身邊的朋友帶著忐忑的心情舉家移民，尋求更好的發展，亦有人繼續留在這片土地。移民潮令人才流失，機構人手短缺更加嚴重。近年來因疫情關係，伊青的會員活躍度不高，人數持續下降，吸納新會員已經成為我們恆常的工作。

我們了解到在逆境中，青年人承受很大的壓力，會感到氣餒，甚至放棄希望。作為香港穆斯林團體，我們努力從宗教教育中，提升人們的信仰，使他們在無常的人生中，學習處變不驚，安然和堅強地應付挑戰。

Amendment Of The Articles Of Association

修改公司章程

In view of the Abolition of Memorandum of Association by the Company Registry and the Company Ordinance (Cap 622) commenced operation in March 2014, an organization only required the Articles of Association. Hence, HKIYA held an Extraordinary General Meeting on 24th April 2021 to enact and approved the latest Articles of Association with several amendments according to the latest statutory framework.

The last Memorandum and Articles was adopted in 2000 and over the years, there has been modification from the Inland Revenue Department (IRD) and Companies Registry (CR) and a newly revised Articles was suggested and amended by P.T. Yeung & Tang company.

The major changes including the members of council are named as Directors of the organization; the compulsory filing of Audited Financial Report to the Inland Revenue; the age of the Director changed from 50 to 55, reducing council members number from 11 to 5 people and the term of officers are altered from 1 year to 3 years.

鑑於公司註冊處於2014年3月廢除了組織章程大綱及公司條例(第622章)，自始所有在香港成立的法團只需要組織章程細則。因此，本協會於2021年4月24日召開了特別會員大會，並根據最新的法定框架制定和審批了最新的法團章程細則，並進行了多項修訂。

本協會上一份章程大綱和章程細則於2000年通過，多年來，稅務局 (IRD) 和公司註冊處 (CR) 均對章程細則提出了立法及修改，而本協會新修訂的章程細則由楊彼得律師行協助修訂。

新修訂的章程細則主要的修訂包括所有委員重新命名為董事；向稅務局提交財務報表；董事年齡由50歲延至55歲，法定董事人數由最少11人減至5人；董事任期由1年期改為3年。

HKIYA Scholarship - IDPMPS Class Dojo Reward Scheme

香港伊斯蘭青年協會 – 伊鮑小Class Dojo獎勵計劃

IDPMPS strives to build a positive community where the learning environment is welcoming, pleasant and safe. In this regard, the Dojo Reward Scheme has been implemented since the 2020-2021 academic year. Dojo points are given to students once they present good performance in academics, conduct, serving others and competitions. Teachers are definitely committed in this scheme and so are the students as they are highly motivated to get the Dojo points, not just face to face classes but also via Zoom. Applaudably, almost 100% of the students met the minimum requirement of getting Dojo prizes. Hong Kong Islamic Youth Association (HKIYA) is supportive of this scheme and gave a donation of \$3,500 for students with outstanding performances. After the year-long efforts, the top six students with the most dojo points were awarded the “HKIYA Scholarship” at the graduation ceremony. Shumaila Naz of Class 3C successfully obtained over 1,000 points which was the highest and was also awarded “The Top Student of the Year”. The other top five students who achieved over 900 points received the “Diamond Award”.

由於伊斯蘭鮑伯濤紀念小學一直致力營造充滿鼓勵、愉快和安全的學習環境，所以由2020-2021學年起便開始推行「Class Dojo獎勵計劃」。學生只要在學業、品行、服務他人或比賽中表現積極，甚至獲得理想成績時，老師就會給予他們Class Dojo 積分，以作表揚。伊鮑小的老師不但重視學生能否全面地健康成長，而且在課堂上常常高度讚揚學生的努力。更值得欣喜的是，幾乎所有學生都達到了獲得Class Dojo獎勵的基本要求。

伊青為了對這別具意義的獎勵計劃表達支持，向伊鮑小捐贈了\$3,500作為獎學金來獎勵於計劃中表現出色的學生。經過一年的努力，獲得積分最多的六名優等生均在畢業典禮上獲頒「伊斯蘭青年協會獎學金」。而3C班沈曼娜同學更成功取得超過1000分的最高積分，獲頒「年度最佳學生」；其他取得900分以上的前五名學生也分別獲頒「鑽石獎」。

On the morning of July 18, 2021, the sky was dark and drizzly, but the cheers on the rooftop made this depressing morning a happy one.

Grip the bat tightly, step to the front and then swing with full power. The ball quickly swept across the falling raindrops reaching the fence of the rear and then the ball fell to the ground immediately. Cheers and sighs filled the entire rooftop.

This day was the first friendly match of the HKIYA Cricket Team-"Tin Shui Wai United" since it was formed in October 2020 as a team. Although the game was almost cancelled due to the rain, thanks to Allah, it was only a drizzle by and during the game time. After the coach's assessment, the game could go on, and the sky even started to clear in the middle of the game such that the whole friendly match was successfully completed. Alhumdulillah.

They were divided into two teams and played various games with two strong opponent teams, Pitch Smasher and CMACCK. In actual combat, not only did the team further improve, but it also ignited the fiery fighting spirit of the players and let them look forward to be better. This had led them wanting to play against different strong teams in the future and even participate in the official cricket tournament, InshAllah.

Appeal Letter to Foreign Embassies & Consulates

致外國大使館和領事館的關注信

We, the Hong Kong Islamic Youth Association strongly condemn the terror attack by the Israeli forces and settlers on the Palestinians at the Al-Aqsa Mosque and in the occupied East Jerusalem neighbourhood of Sheikh Jarrah. On 21st May 2021, the HKIYA Chairperson and Sister Aminah Chu arranged a special visit to several different Consulates including Consulate General of The State of Kuwait, Consulate General of Turkey, Consulate of Hashemite of Jordan in HKSAR, and Consulate General of the State of Qatar in HKSAR. We presented them the letter and a hand-painted picture to express our deep concerns about the Israeli forces raiding the Al-Aqsa Mosque in the occupied East Jerusalem and rudely displaced the worshippers and harming many Palestinians. We urge the Muslim ummah to unite and hope that other Muslim-majority countries can take action to cease the brutality of Palestine because such actions constitute a flagrant violation of international law and pose a security threat to the global world.



ACCOUNTING POLICIES AND EXPLANATORY NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 AUGUST 2021

1 GENERAL INFORMATION

The Association, being a company limited by guarantee, was domiciled and incorporated in Hong Kong under the old Companies Ordinance (Chap. 32) on 26 May 1999. Under the provisions of its memorandum and articles of association, every member shall, in the event of the Association being wound up, contribute to the assets of the Association to the extent of HK\$1. As at 31 August 2021, the Association had 431 registered members.

The Association is principally engaged in the promotion of Islamic principles and the encouragement of its members to study and practise Islam. The address of its registered office is 8/F., O.R. Sadick Islamic Centre, No. 40 Oi Kwan Road, Wanchai, Hong Kong.

These financial statements are presented in the functional currency, viz. Hong Kong dollars.

2 BASIS OF PREPARATION AND ACCOUNTING POLICIES

The Association qualifies for the reporting exemption as a small guarantee company under section 359(1) of the Hong Kong Companies Ordinance (Cap. 622) and is therefore entitled to prepare and present its financial statements in accordance with the Small and Medium-sized Entity Financial Reporting Standard (SME-FRS) issued by the Hong Kong Institute of Certified Public Accountants (HKICPA).

These financial statements comply with the SME-FRS and have been prepared under the accrual basis of accounting and on the basis that the Association is a going concern. The measurement base adopted is the historical cost convention.

The following are specific accounting policies that are necessary for a proper understanding of the financial statements:

(a) Revenue recognition

Provided that it is probable that the economic benefits associated with the revenue transaction will flow to the Association and the revenue and costs, if any, in respect of the transaction can be measured reliably, revenue is recognised as follows:

- (i) Subscriptions and donations are recognised as revenue when the subscriptions or donations are received.
- (ii) Interest income is recognised on a time proportion basis taking into account the principal outstanding and the interest rate applicable.

ACCOUNTING POLICIES AND EXPLANATORY NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 AUGUST 2021 - continued

2 BASIS OF PREPARATION AND ACCOUNTING POLICIES - continued

(b) Property, plant and equipment

Property, plant and equipment are stated at historical cost less accumulated depreciation and impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent expenditure is charged to the asset's carrying amount only when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably. All other repairs and maintenance costs are expensed in the income statement during the financial period in which they are incurred.

Depreciation of property, plant and equipment is calculated using the straight line method to allocate cost to their residual values over their estimated useful lives. The annual rate of depreciation for furniture, fixtures and equipment is 20%.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

(c) Investments in securities

Current investments are stated at the lower of cost and net realizable value. Long-term investments are stated at cost less accumulated impairment losses.

(d) Designated funds

All income accruing to and all expenses attributable to designated funds are accounted for directly in each particular fund.

The General Council have the discretion to use or transfer any funds in the furtherance of the objects of the Association except in instances where funds and donations when received for a specific purpose shall not be utilized for any other purpose without the prior approval of the donors.

(e) Foreign currency translation

Foreign currency transactions are translated into the functional currency using the exchange rate prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the income statement.

(f) Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of three months or less.


