Message from the Chairman

Alhamdulillah, we are blessed to enjoy the versatility in this life and take action in the positivity of Islam, even during a time when many people easily make the mistake of equating a committed Muslim to a rigid, conservative or worse, a potential threat for the non-believers in society. As Muslims, we stand firmly by the principles and guidelines of our faith as revealed through our Beloved Prophet Muhammad, *upon him be peace and blessing of Allah*.

Reflecting on the year 2012, the Muslim Ummah continuously faced challenges and created challenges for ourselves as well. The Hong Kong Muslim community continued their efforts in promoting the Islamic ideology through various methods, such as outreaching to the community, interfaith dialogues, publication of books and videos, organizing Islamic talks in universities, having regular classes and activities for Muslim students in collaborations with schools and Madrassahs and much more. This Online Cantonese Islamic Video Channel of HKIYA is solely HKIYA's production with no partnership with any individual or any organization/association. All the hosts and speakers are very supportive volunteers at the request of HKIYA. We pray to Allah Almighty to bless and reward the whole team of Online Video Channel including the hosts, speakers and the technical team lead by Br. Adam Li, for producing high quality and informative Islamic videos. May Allah Almighty also reward and bless our sponsors, who contributed to the noble cause and made the launching of Online Video Channel possible.

Alhamdulillah, HKIYA has also launched an iTunes Apps 'Islam HK'. The 'Islam HK' is a bilingual language Apps. The 'Muslim HK' Apps is a good collection for your iPhone, iPod or iPad, so do download and check it out. Insha'Allah, it will refresh your faith and increases your knowledge by reading the complete translation of the Noble Quran and Book of Sahih Bukhari (*God be pleased with him.*), for free. HKIYA also organized 'The Power of Art' workshop, teaching youngsters the skill of drawing,

painting and sketching. A total of 6 sessions were conducted with the help of Professional Art teacher. The drawings of the youngsters are displayed at the Community Art Gallery in Chai Wan MTR station.

HKIYA continues to expand its network using the multimedia for better publication and promotion of Islam. We have enhanced our HKIYA website, Facebook page, and as mentioned above lots of videos have been uploaded to our YouTube channel. We had also published 'Strive' in March 2012 and July 2012. If you have an interesting and inspiring story or an experience you want to share with the readers of Strive, you are welcome to send it to the Strive Team of HKIYA and together we can publish it, Insha'Allah.

At the request of Islamic Kasim Tuet Memorial College, HKIYA also conducted a Career Planning workshop for S6 students in English and Cantonese. HKIYA shall take up more of such workshops for the empowerment and betterment of the youth.

Throughout the year, HKIYA have worked closely with other Islamic organizations, NGOs and individuals in Hong Kong. Their cooperation and contributions towards the Association's functions have resulted in the successful completion of our programmes. HKIYA Office and Office Helpers

She received a very minimal transportation allowance from the Association. HKIYA sincerely thanks her for her selfless sacrifices, time and efforts in contributing to the success of all events and activities in this year.

Besides, the renovation work in our office at 8/F has been completed. In this regard, office of the HKIYA was relocated back to 8/F, Masjid Ammar & O.R.S. Islamic Centre, 40 Oi Kwan Road, Wan chai, H.K. with effect from 1 November 2012.

Library and Islamic Souvenirs

3. Islamic literatures, DVDs and CDs in our library are available for lending at our office during opening hours. Though some of the books are being distributed freely and are available at our 8/F office. We have also ordered beautiful scarves, prayer mats, and prayer caps which are all available at our office at attractive prices.

Finance

4. For the financial year 2011-2012, the total revenue amounted to HK\$250,524 while the total expenditure was HK\$139,211 (including a fair value loss on avaliable-for-sale financial assets of HK\$2,792). A surplus for the financial year of HK\$111,313 was recorded (comprising of HK\$71,046 from General fund and HK\$40,267 from Designated funds). 8. HKIYA set up a "Youth Development Fund (Student)" ("YDF"), implemented in December 2011. The target group for this YDF is full-time students not over the age of 22 and need financial subsidy in joining our events/activities. We aim at encouraging or assisting the youth in need so that they can join our events/activities without financial restriction.

Individual Major Projects

Cultural and Educational Activities

Career Counseling and Job Searching Skills Workshop

9. Two workshops, in December 2011 and March 2012 respectively, was held. They are career talks for secondary students who will graduate soon. Around 100 students from the graduating classes of Islamic Kasim Tuet Memorial College took part in these two workshops. Also, students were briefed on job searching skills and equal opportunity issues.

Happy Friday on Islam

10. HKIYA initiated a program named "Happy Friday in Islam" on every Friday evening starting from April 2012 and ended before Ramadan in this year at the 2nd floor of the Chinese Muslim Cultural and Fraternal Association ("CMCFA"). This was a Cantonese program in the form of lectures and small group discussions on different Islamic topics. We also thank our co-organiser, CMCFA.

Visit to the Hong Kong Jockey Club Drug Info Centre

11. A visit to the Hong Kong Jockey Drug Info Centre was organised in August for the youth to help raise their awareness of the Anti-drugs. A short talk on drugs was also given to increase their knowledge on the subject promote an anti-drug and healthy lifestyle.

Architectural Walking Tour

12. On 25th August, 2012, HKIYA organized an archiectural walking tour with the aim of gaining more insight of the architecture of the Central district. 12 people attended in total. The walk was lead by a local architect and started from the Central MTR station, passing the Bank of China tower all the way up to the Shelly Street Mosque where participants concluded their learning experience. On the way, buildings' structure, history and their architectural background were introduced.

Hong Kong Da'wah Program

13. Under the guidance of almighty Allah, this year, HKIYA had initiated a series of Da'wah Programs, in order to introduce Islam to more people in the local community. The HKIYA Da'wah Program Launching Party was held on 15 July 2012 (Sunday) at Wanchai Masjid to introduce our Online Video Channel (OVC) and Apple iOS App "IslamHK". More than 70 members and Muslim brothers and sisters attended and gave us great support and valuable comments. We would like to thank everyone for their suggestion and we promise to work on this even harder in the coming year, insha Allah.

Welfare Activities

38th Annual Dinner

14. On 18 December 2011, HKIYA organized its Annual Dinner at the 6/F Seminar Room, O.R. Sadick Islamic Centre. We offered souvenirs to volunteers who have helped in organizing HKIYA activities during the year and also attractive prizes for participants of the Annual Dinner. More than 70 members attended.

Zakat to Victims in Mindanao Philippines Flood

15. Hong Kong Islamic Youth Association has distributed Zakat to victims of the Mindanao Philippines Flood for providing much needed medicines, clean water, tents and essential emergency items to assist those affected by the flood.

Zakat to Victims in Pakistan Flood 2012

16. HKIYA has distributed Zakat to the victims of The heavy rain and floods that has devastated Pakistan. Millions of people have been affected by the flood as their livestock, houses, bridges and communication infrastructure has been washed away by severe floods.

Zakat to Poor Muslims in China, Pakistan and Indonesia

17. HKIYA has distributed Zakat in China, Pakistan and Indonesia to provide basic needs such as clean water and daily essentials for poor muslims.

Zakat to Poor Muslims in Thailand

18. HKIYA has distributed Zakat to help poor muslims in masjids and schools in Thailand.

Zakat to Rohingya refugees in Myanmar

19. HKIYA has distributed Zakat to Rohingya refugees in Myanmar in hopes of providing the refugees with daily essentials such as shelter and food.

Public Relation

RISEAP Northern Zone Youth Leadership Training Camp

20. RISEAP organized a 4 days youth leadership training camp for the northern zone countries in late August. The camp was held from 22 to 25 August, 2012 on Jeju Island in Korea and HKIYA was invited to nominate one youth to join the camp. One of our council members was appointed to take part in the camp. All travel expenses were coved by RISEAP. Camp program included lectures and discussions about Islamic situation in different northern zone countries. The youth were able to have exchange with students from Jeju Halla university, Taiwanese and Japanese youth, and foreign Muslim students. The camp was also accompanied by a cultural tour around Jeju Island.

Children Eid Party 2012

21. The Children Eid Party was organized by Hong Kong Islamic Youth Association and the CMCFA at the community hall of CMCFA on 2 September, 2012 to celebrate Eid after Ramadhan with the children. A lot of games were played with the children with lots of prizes and gifts being given out. The children and their parents had a great time. We sincerely thank Br. Sat Chi-sang for sponsoring the total cost of this event.

Eid Carnival at Islamic Kasim Tuet Memorial College

22. Our association took part in the Eid fair organized on 18 November, 2012 by Islamic Kasim Tuet Memorial College. HKIYA had a stall for selling Islamic souvenirs and homemade fruit jam.

Artwork Display at Community Art Galleries in MTR station

23. Our association has successfully registered for the Community Art Gallery display board at the Chai Wan MTR station to give our members an opportunity to display their art work. For that, we are going to hold a creative drawing workshop on 17 November, 2012 for children and the youth to create Islamic Art for display.

Recreational Activities

Youth Art Workshop – Power of Art

25. This was a two-part workshop for teens and children ranging from 8-15 years old, with 5 classes in total. The purpose of the workshop was to let the students understand that painting has no boundaries. The workshop introduced basic painting skills such as drawing, water coloring, and the basic concepts of color, composition and use of space with the aim of helping students to master the skills to draw.

Part 1 of the workshop was organized on 3, 10 and 17 March, 2012 at the 4/F of the O.R.S. Islamic Centre and the Visual Art Centre while the second part of the Youth Art Workshop was organized on 22 and 29 August, 2012. Through the activity, participants were able to draw with the use of crayons and watercolor. A total of 80 students took part in this workshop. Many thanks to our volunteer instructor.

Visit to Ocean Park

26. A sponsored full day visit to Ocean Park was organised on 23 June, 2012 for the youth as part of the Summer programme. Approximately 33 members attended this activity, including parents and children. The children had a great time with the exciting rides and interesting animals in the park.

Visit to the new Legco Complex

27. A visit to the new Legco complex was organized on 26th August, 2012 morning. The aim of this visit was to let students learn more about Hong Kong's legislative council and increase their interest in this aspect. The participants also got the to take part in a role-play activity to increase their knowledge on the law.

Paper-cutting with the Master and Visit to the Jockey Club Creative Arts Centre

28. On 22 April. 2012, a visit to the Jockey Club Creative Arts Centre was organized and 30 people attended in total. Participants consisted of students between 6 and 16 years old. They learnt the basic techniques of Chinese style paper-cutting on subjects such as animals and Chinese lanterns. Paper-cutting was followed by a tour around the Creative Arts Centre which included art studios of many local artists. Everyone had a great time. We have also uploaded videos on HKIYA activities highlights to our Youtube channel. We hope to provide more Da'wah opportunity through our Youtube channel.

After the launching of OVC, there were more than 16,500 views and more than 50 subscribers of our Youtube channel. We are providing 3 regular channels at the present: "Imam Channel", "Muslim Chat" and "History Chamber" which are updated on every Monday, Wednesday and Friday respectively.

Apple iOS App "ISLAMHK" for iPhone and iPad

31. HKIYA successfully developed a totally <u>FREE</u> Islamic App which has been available on Apple App Store starting from 21 August, 2012. This App includes a complete Qur'an (in Arabic) and its Chinese and English translations; Sahih Bukhari Hadith in English and Chinese; Islamic books and videos. So far, this App has been downloaded by more than 450 people from more than 30 countries/ areas across the globe, inlcuding Hong Kong, the United States, China, the United Kingdom, Singapore etc. You are welcome to download it and share this with your family and friends.

NOTES TO THE FINANCIAL STATEMENTS

1 GENERAL INFORMATION

The Association, being a company limited by guarantee, was domiciled and incorporated in Hong Kong under the Companies Ordinance on 26 May 1999. Under the provisions of the Association's memorandum and articles of association, every member shall, in the event of the Association being wound up, contribute to the assets of the Association to the extent of HK\$1. As at 31 August 2012, the Association had 205 registered members.

The Association is principally engaged in the promotion of Islamic principles and the encouragement of its members to study and practise Islam. The address of its registered office is 8/F., O.R. Sadick Islamic Centre, No. 40 Oi Kwan Road, Wanchai, Hong Kong.

These financial statements are presented in the functional currency, viz. Hong Kong dollars.

2 BASIS OF PREPARATION AND ACCOUNTING POLICIES.

These financial statements have been prepared in accordance with the Hong Kong Financial Reporting Standard for Private Entities (HKFRS for Private Entities) issued by the Hong Kong Institute of Certified Public Accountants (HKICPA) and the requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, as modified by the revaluation of financial assets which are carried at fair value.

(a) Revenue recognition

Provided that it is probable that the economic benefits associated with the revenue transaction will flow to the Association and the revenue and costs, if any, in respect of the transaction can be measured reliably, revenue is recognised as follows:

- Subscriptions and donations are recognised as revenue when the subscriptions or donations are received.
- (ii) Interest income is recognised on a time proportion basis taking into account the principal outstanding and the interest rate applicable.

(b) Property, plant and equipment

Property, plant and equipment are stated at historical cost less accumulated depreciation and impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent expenditure is charged to the asset's carrying amount only when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably. All other repairs and maintenance costs are expensed in the income statement during the financial period in which they are incurred.

Depreciation of property, plant and equipment is calculated using the straight line method to allocate cost to their residual values over their estimated useful lives. The annual rate of depreciation for furniture, fixtures and equipment is 20%.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

NOTES TO THE FINANCIAL STATEMENTS - continued

2 BASIS OF PREPARATION AND ACCOUNTING POLICIES - continued

(c) Investments in available-for-sale financial assets

Available-for-sale financial assets are included in non-current assets unless management intends to dispose of the investment within 12 months of the balance sheet date. They are carried at fair value with changes in fair value recognised in the income statement. When securities classified as available-for-sale are sold or impaired, the accumulated fair value adjustments are included in the income statement as gain or losses from investment securities.

(d) Designated funds

All income accruing to and all expenses attributable to designated funds are accounted for directly in each particular fund.

The General Council have the discretion to use or transfer any funds in the furtherance of the objects of the Association except in instances where funds and donations when received for a specific purpose shall not be utilized for any other purpose without the prior approval of the donors.

(e) Foreign currency translation

Foreign currency transactions are translated into the functional currency using the exchange rate prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the income statement.

(f) Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of three months or less.

文教活動

職業輔導及求職技巧工作坊

09. 本會分別於 2011 年 12 月及 2012 年 3 月於伊斯蘭脫維善紀念中學舉辦了兩次工作坊,希望協助一些畢業生深入認識本地的工作市場。這次活動共有 100 名學生參加,並讓學生們認識一些求職技巧,提升他們對本地市場的意識。

周五聚一聚

10. 本會及中華回教博愛社合辦了一項名為『周五聚一聚』的活動。由 2012年4月起至本年齋戒月之前,於逢週五以討論會形式在中華回 教博愛社2樓舉行,每次討論了不同的伊斯蘭內容。

參觀香港賽馬會藥物資訊天地

11. 本會希望傳遞禁毒訊識給青少年,所以於本年8月舉辦了一個參觀 位於金鐘的香港賽馬會藥物資訊天地的活動。當天的活動亦包括禁 毒講座,目的在向青少年推廣健康的生活方式。

中區建築步行遊

12. 中區建築步行遊是在 2012 年 8 月 25 日舉行的,大約有 12 人參加。 這次活動讓參加者有機會認識中環區建築的特色。當天,參加者由 中環地鐵站步行到些利街清真寺,沿途有建築師為他們解釋各種建 築物的背景和歷史,以增加各人的興趣。

菲律賓棉蘭老島水災災民

2012 巴基斯坦水災

16. 香港伊斯蘭青年協會向巴基斯坦受暴雨洪災影響的災民發放天課。 有幾百萬人因水災喪失家園,牲畜,橋樑及通訊基礎設施都被水災 沖走了。

援助中國,巴基斯坦及印尼教胞

17. 香港伊斯蘭青年協會向中國,巴基斯坦及印尼的教胞提供改善其生活的必需設備,清潔飲用水和日用品。

援助泰國賀肥吉慶清真寺清貧穆斯林

18. 香港伊斯蘭青年協會向泰國賀肥吉慶清真寺的清貧穆斯林分發天課。

援助緬甸羅興亞難民

19. 香港伊斯蘭青年協會向緬甸羅興亞難民分發了天課,用來為他們提供生活必需用品,例如食物和日用品。

推出 OVC 節目後,本會 YouTube 錄影頻道的訪客人數有顯著的上升。本頻道錄得超過 16,500 個觀看率及超過 50 位訂戶。到目前為止,OVC 有三個不同的節目: "阿訇在線"、"穆談天下事"及"古今會客室",分別於逢星期一、三、五更新。

蘋果 iOS 手機、平板電腦應用程式 "ISLAM HK"
